The Executive Council of Physical Therapy and Occupational Therapy Examiners files this notice of its intent to review Chapter 651, concerning fees, in accordance with Texas Government Code §2001.039.

An assessment will be made by the Executive Council of Physical Therapy and Occupational Therapy Examiners as to whether the reasons for adopting or readopting the chapter continue to exist. This rule review will be conducted pursuant to Texas Government Code, §2001.039. The Board will accept comments for 30 days following publication of this notice in the *Texas Register* as to whether the reasons for adopting these rules continue to exist. The assessment made by the Board indicates that the reasons for initially adopting the chapter do continue to exist.

Credit Union Department

Title 7, Part 6

The Credit Union Commission (Commission) has completed its review of Texas Administrative Code, Title 7, §§91.302 (Election or Other Membership Vote By Electronic Balloting, Early Voting, Absentee Voting, or Mail Balloting), 91.310 (Annual Report to Membership), and 91.315 (Members' Access to Credit Union Documents) as published in the December 18, 2015, issue of the *Texas Register* (40 TexReg 9319).

The rules were reviewed as a result of the Credit Union Department's (Department) general rule review, which was conducted in accordance with Texas Government Code §2001.039.

The Department hereby certifies that the proposal has been reviewed by legal counsel and found to be within the Department's legal authority to readopt.

The Commission received no comments with respect to these rules. The Department believes that the reasons for initially adopting these rules continue to exist. The Commission finds that the reasons for initially adopting §§91.302, 91.310, and 91.315 continue to exist and readopts these rules without changes pursuant to the requirements of Government Code, §2001.039.

Texas Board of Veterinary Medical Examiners

Title 22, Part 24

The Texas Board of Veterinary Medical Examiners (Board) has completed the review of Texas Administrative Code, Title 22, Part 24, Chapter 573 (Rules of Professional Conduct) in its entirety.

Notice of the review of Chapter 573 was published in the December 4, 2015, issue of the *Texas Register* (40 TexReg 8705). No comments were received in response to the notice.

The Board believes the reasons for initially adopting Chapter 573 continue to exist. However, the Board has determined that certain revisions and amendments may be appropriate and necessary. Proposed amendments and revisions to Chapter 573, with discussion of the justification

for the proposed changes, will be published in the *Texas Register* at a later date.

Accordingly, the Board finds that the reasons for initially adopting these rules continue to exist and readopts Chapter 573 in accordance with the requirements of Texas Government Code §2001.039.
