Proposed Rule Reviews

Texas State Board of Plumbing Examiners

Title 22, Part 17

In accordance with Texas Government Code §2001.039, the Texas State Board of Plumbing Examiners (the Board) files this notice of intent to review its rules under Title 22, Part 17 of the Texas Administrative Code.

The Board will conduct a review of its rules on a chapter-by-chapter basis and individual notices of intent to review all rules under each chapter will be published in the Rule Review section of the *Texas Register*. An assessment will be made by the Board as to whether the reasons for adopting or readopting the rules continue to exist. Readopted rules will be noted in the Rules Review section without publication of the text. Any proposed amendments or repeal of a rule or chapter as a result of the review will be published in the Proposed Rules section of the *Texas Register* and will be open for a 30-day public comment period prior to final adoption or repeal.

The Board will conduct a review of its rules by chapters; however, the Board may review a chapter as part of its routine rulemaking before its scheduled review date if it is necessary to propose amendments to a chapter.

The review of the chapter 361 will begin August 1, 2016, and will be concluded by October 31, 2016.

The review of the chapter 363 will begin November 1, 2016, and will be concluded by January 31, 2017.

The review of the chapter 365 will begin February 1, 2017, and will be concluded by April 30, 2017.

The review of the chapter 367 will begin May 1, 2017, and will be concluded by July 31, 2017.
